### **Eligibility Criteria**

#### **Qualification:**

Education qualification for BTO program shall be 16 years of education preferably in Commerce, Business, Economics or other disciplines relevant to Banking with minimal 60% marks or equivalent from reputed and HEC recognized universities and colleges.

Please note that only those candidates shall be considered for inclusion in the selection process that have completed their relevant degree and have in hand final transcript or degrees in original.

#### **Age:**

**For Men:** Maximum age limit shall be 26 years as on the closing date of submission of application form.

**For Women:** As per policy of the bank, age relaxation for up to 03 years is allowed to all female applicants (on the closing date of submission of application form).

- Application form can be filled online on National Testing Services (NTS) website ([www.nts.org.pk](http://www.nts.org.pk)).  
**Note:** NTS will not issue Roll No Slips through courier/postal service to any candidate. Eligible candidates shall take print out of their Electronic Roll No Slip (having picture of candidate) through NTS website for appearing in the tests.
- Please submit your test fee Rs. 460/- via ILink 1Bill Participating Banks/ATM/Internet Banking/Mobile Banking/Easy Paisa/Jazz Cash/TCS Express Counters. Only 1Bill Invoice payment will be accepted.
- Applications must be received latest by February 13, 2022.
- Application submitted in person will not be entertained.

**Written Test will be conducted by National Testing Service-Pakistan. All candidates will be provisionally allowed to appear in the written test administered by NTS. However, if any candidate is found Ineligible he/she can be disqualified at any stage of the Recruitment Process.**
